### **Sustainable Agricultural Lands Conservation** (SALC) OVERVIEW

The SALC Program is dedicated to preserving California's vital agricultural lands by preventing their conversion to non-agricultural uses. SALC is funded by revenue from the California Climate Investments Fund, which is derived from cap-and-trade auction proceeds.

Funds for this brochure were made available through Strategic Growth Council's Sustainable Agricultural Lands Conservation Program (SALC) in collaboration with the Department of Conservation. SALC is part of California Climate Investments, a statewide initiative that puts billions of Cap-and-Trade dollars to work reducing greenhouse gas emissions, strengthening the economy, and improving public health and the environment - particularly in disadvantaged communities.






### **Understanding** the Sustainable **Agricultural** Lands **Conservation Program**





### **Program Benefits:**

- Defending and preserving the legacy of farming, supporting wildlife habitats, and minimizing land fragmentation.
- Fostering a thriving and varied economy while promoting local food production.
- Safeguarding rural ambiance, cultural legacies, and overall quality of life.
- Promoting groundwater recharge, mitigating runoff, and reducing risks of flooding.

#### The Primary Goals of SALC:

### Preventing Conversion of Agricultural Land:

The primary goal is to prevent the conversion of farmland and rangeland to non-agricultural uses, thus preserving these valuable lands for agricultural production.

## Reducing Greenhouse Gas Emissions:

By preventing the conversion of agricultural land, SALC aims to reduce greenhouse gas emissions that would result from urban and suburban development.

# Promoting Sustainable Agricultural Practices:

The program supports sustainable agricultural practices that conserve natural resources, maintain biodiversity, advance carbon sequestration, and enhance environmental quality especially concerning water.

# Supporting Local Economies and Communities:

SALC seeks to support local economies and communities by maintaining the viability of agricultural operations and preserving the cultural heritage and scenic beauty of rural areas through encouraging compact and walkable development.

# **SALC** Agricultural Conservation Acquisition Grants:

Provide funding to permanently protect croplands, rangelands, and lands used for traditional resources from conversion to non-agricultural uses.

Grants awarded will be for 90% of the appraised conservation easement value. Grant funding does not provide the easement endowment, which may be contributed by the landowner from the proceeds obtained from the sale of the conservation easement.

### Eligibility & Application Process:

- Applications can be submitted by cities, counties, regional park, open-space, or resource conservation districts, non-profit organizations, and tribes.
- Proposed projects must aim to permanently protect lands from conversion to non-agricultural uses. Eligible lands include viable agricultural land and cultivated or non-cultivated land used for gathering and traditional uses, so long as such activities are led or conducted in partnership with an eligible California Native American tribe.
- Projects must demonstrate benefits to the other program goals of reducing greenhouse gas emissions, promoting sustainable agricultural practices, and supporting local economies and communities.
- The application process is statewide and annual.
  Pre-proposals are due in January.
